
**RESOLUTION 2025-10

**SUMMARY FOR PUBLICATION OF ORDINANCE 2025-04:
AN ORDINANCE AMENDING THE CREDIT RIVER CITY ZONING CODE PERTAINING TO
CANNABIS AND HEMP BUSINESSES**

The City Council for the City of Credit River, Scott County, Minnesota, hereby ordains that on the 3rd day of March 2025, the City Council for the City of Credit River adopted the above Ordinance. Due to the lengthy content of the Ordinance, a brief summary follows:

Ordinance 2025-04 as adopted amends the Zoning Code of the City of Credit River to include regulations regarding cannabis and hemp businesses operating within the City.
